EU Sanctions

- On 2 March 2022, the European Council introduced sanctions that prohibit the broadcasting activities of Russian state outlets Sputnik and RT within the EU or directed at the EU.
- Consequently, major social media platforms suspended the accounts of Russian state media in Europe.
- While studies concur on the overall effectiveness of the introduced sanctions in limiting EU access to Russian state outlets, these outlets have employed a wide range of circumventing strategies.
- Understanding these strategies and how to detect them can help improving the design and implementation of both existing and new sanctions.


- Discovery (Google searches)
- Attribution (Maltego)




- Spread on social media (Brandwatch/CrowdTangle)
- Web traffic analysis* (SimilarWeb) (*Big caveat: VPNs)

Circumventing Strategies: A Case Study On Alternative RT Domains (3/5)




Spread of alternative RT domains on Facebook (red) and Twitter (blue) from 1 February 2022 to 30 June 2022.


- Posts containing links to these websites were shared over 450,000 times on Twitter by almost 50,000 unique users.
- On Facebook, there were over 6,000 shares from around 1,200 public Facebook pages and groups, with a combined followership of over 46.7M users.
- In the period under analysis, these sites totalled about **2.5M** views/month.
- This said, overall drop in EU traffic to RT was significant, moving from 52M visits/month in early 2021 to 14M in June 2022 (-74%).




Spread of different alternative RT domains by the Twitter account ActualidadRT, from 1 February 2022 to 30 June 2022.

Other Circumventing Strategies

- 1) Mirror domains, alternative domains, copy-paste websites
- 2) Rebranding of content
- 3) Expansion of online presence on alternative platforms
- 4) New media set up by former RT employees
- 5) Use of diplomatic accounts
- 6) Promoting usage of VPNs

Impact of Sanctions: Successes, Challenges and Recommendations

Successes

- Restrictions placed on accessing Russian state media were overall effective in reducing traffic from the countries that applied the sanctions;
- Engagement with sanctioned social media accounts also decreased in the aftermath of the bans.

Challenges and Recommendations

- Sanctioning a fixed set of assets has its limits;
- Sanctioned content can easily be recreated and spread through other media;
- Sanctions were only applied to the most well-known state media outlets;
- State-affiliated actors are not the only actors spreading pro-Kremlin disinformation.
